

+ LGBTQIA

- The first three letters refer to sexual orientation (Lesbian, gay, bisexual)
- The "T" refers to issues of gender identity
- The "Q" refers anyone who chooses to identify as such which can include, but is not limited to, gay, lesbian, bisexual, transgender, intersex and asexual people
- The "I" is a term to describe a person whose biological sex is ambiguous
- The "A" refers to an Ally, a supporter and advocate for the LGBTQIA population
- + Cisgender
 - Term used to describe people who identify with the gender they were assigned at birth

 \bigstar Why say 'cisgender' instead of 'non-transgender'? Because, referring to cisgender people as 'non trans' implies that cisgender people are the default and that being trans is abnormal.

WHAT DOES TRANSGENDER MEAN?



+ Transgender

 Umbrella term used for people whose gender identity differs from what is typically associated with the sex they were assigned at birth. May include: trans women, trans men, gender fluid/ gender non-conforming folks

WHAT DOES QUEER MEAN?

Queer

- An umbrella term to refer to all LGBTQI people
- A political statement, as well as a sexual orientation, which advocates breaking binary thinking and seeing both sexual orientation and gender identity as potentially fluid.

GENDERQUEER:

Someone who resists categorizing their gender identity. They may identity somewhere in the middle of the gender spectrum or as neither gender. Genderqueer people often use gender neutral pronouns such as "they / them."




WHAT IS THE DIFFERENCE BETWEEN TRANS, DRAG AND CROSS-DRESSING COMMUNITIES?

+ Transgender community

- Trans includes people who identify at transsexual, genderqueer, non-binary, androgyne, two sprit, etc.
- Drag community
 - Performers who cross-dress for the purpose of entertaining, and the majority of drag queens are not trans women
- Cross-dressing community
 - Wears the clothing and accouterments of the "opposite sex," and unlike transsexuals, they do not seek to live full-time as the opposite sex. Formerly referred to as the pejorative term "transvestites," cross-dressers are often heterosexual men who wear feminine clothing part-time. Some trans people have a cross-dressing history, while not all cross-dressers are trans.

HOW DOES SEXUAL ORIENTATION DIFFER FROM GENDER IDENTITY?

- Gender identity is your own, internal, personal sense of being a man or a woman
- Sexual orientation describes a person's enduring physical, romantic, and/or emotional attraction to another person
- Transgender people may be straight, lesbian, gay, bisexual or queer
- Gender identity is your own internal, personal sense of self on the gender spectrum; whether it be masculine, feminine, or somewhere in between






- ★Some trans* people medically transition (with hormones and/or surgery) to align their bodies with their gender identity, while some do not.
- ★Gender identity and sexual orientation are distinct; for example, a trans woman might identify as hetero, as a lesbian, as queer, or as anything in between.
- ★ "Transgendered" is not a word! No one gets "transgendered."
- \star Transgender is an adjective and not a noun.
- WRONG: "Tony is a transgender" or "the parade included many transgenders."
- **RIGHT: "Tony is a transgender man" and "the parade included many transgender people."**

ETIQUETTE:

ALWAYS use the chosen name of a trans person (yes, that mean's it's Chelsea Manning, people). If someone introduces themselves as "Fantasia" but their drivers license says "Darnell," they are Fantasia to you always and forever.



★ When in doubt, go with how the person is presenting themselves. If you think someone might be trans, is wearing feminine clothing and introduces themselves as "Diana," using a feminine pronoun is a safe bet.

★ A simple, "Hey, what pronoun do you prefer?" is appreciated.

★ You can also use a gender neutral pronoun like "they." A lot of trans people go by "they" and "them" full-time, avoiding gendered pronouns altogether.



WHY IS TRANSGENDER EQUALITY IMPORTANT?

- Multiracial transgender and gender nonconforming people often live in extreme poverty, with 23% reporting a household income less than \$10,000/year
- Transgender people face mistreatment at work as 62% are harassed, 12% physically assaulted and 9% sexually assaulted
- Most countries and states offer no legal protection in housing, employment and health care. Multiracial transgender people (27%) have reported being refused medical care





WHAT DOES TRANSGENDER INEQUALITY LOOK LIKE IN REAL LIVES AND IN REAL TIME?

- Transgender and gender non-conforming people face injustice in every turn
- Key findings from a study by the National Gay and Lesbian Task Force and the National Center for Transgender Equality:

41% of respondents reported attempting suicide

Respondents were **4X more likely to live** in poverty than the general population and

1 in 5 reported experiencing homelessness once in their lives

Those who expressed a transgender identity in school reported alarming rates of

harassment (78%), physical assault (35%), & sexual violence (12%)

U.S. Department of Education Extends Protections to Trans Students



HOW TO RESPECT A TRANSGENDER PERSON

- Be with people unconditionally, as you would be with any other person, especially where gender is a non-topic in life
- Watch your past tense. When talking of the past try not to use phrases like "when you were a previous gender" or "born a man/woman"
- + Use language appropriate to the person's gender
- + Respect the transgender person's need for privacy
- + Begin to recognize the difference between gender identity and sexuality
- + Treat transgender persons the same
- Be supportive
